



# <u>Fixed penalty notices issued under COVID-19 emergency health regulations by police</u> forces in England and Wales

#### **Introduction**

This release presents the latest data on the police use of COVID-19 enforcement notices issued under all emergency health protection regulations in force as at 18<sup>th</sup> April 2021<sup>1</sup> (and includes revisions to previously published figures).

Data on FPNs issued in England and Wales is collated centrally by the ACRO Criminal Records Office and cover the 43 territorial forces, the British Transport Police (BTP) and Ministry of Defence Police.

The figures below relate to enforcement activity by police forces and these data should be seen in the context of wider police activity to engage with the public to explain and encourage compliance with the new regulations. As outlined in previous releases, the police have recorded hundreds of thousands of Covid-19 related incidents since the 27<sup>th</sup> March 2020. This will include incidents where officers have proactively offered advice to people, responded to reports from the members of the public about breaches of the regulation by others and offences where criminals have sought to take advantage of the pandemic to commit a crime.

# <u>Headline figures for FPNs issued under the Health Protection (Coronavirus, Restrictions)</u> <u>Regulations, England and Wales</u>

In total, 110,322<sup>2</sup> notices have been recorded as having been issued in England (99,742) and Wales (10,580) between Friday 27<sup>th</sup> March 2020 and Sunday 18<sup>th</sup> April 2021.

#### In England:

- 15,945 notices were issued under number one regulations;
- 571 under number two regulations;
- 320 for holding a gathering of more than 30 people;
- 1,104 in relation to breaches of local "lockdowns";
- 2,909 under the "Local COVID-19 alert levels";
- 7,123 under number four regulations (national restrictions);
- 69,927 notices issued under the "All Tiers" regulations:
  - 18 notices for Tier 1 (Medium);
  - 1,070 notices for Tier 2 (High);
  - 3,743 notices for Tier 3 (Very High);
  - 65,096 notices for Tier 4 (Extremely High); 61,524 of which were issued from 6<sup>th</sup> January 2021 when national restrictions came into force.
- 1,843 were issued under the steps regulations:
  - 1,657 notices for Step 1
  - 186 notices for Step 2

#### In Wales:

- 2,664 notices were issued under number one regulations;
- 176 notices were issued under number two regulations;
- 284 notices were issued under number three regulations;
- 658 notices were issued under number four regulations;
- 6,790 notices have been issued under number five regulations;
- 3 notices were issued under regulations relating to holding a gathering of more than 30 people; and,
- 5 notices were issued under the International Travel Regulations (ITRs).

Chart 1 shows previously published figures for earlier reporting periods together with the latest revisions as more FPNs have been processed. In earlier releases this was reported on a daily basis but, given the length of time these regulations have been in place, this is now summarised on a weekly basis. The following analysis and the chart below do not include fines issued under the face covering regulations, business regulations or ITRs. Separate analysis is presented in the sections below for these FPN types.

There were steep rises in the number of FPNs issued following the week of 18<sup>th</sup>-24<sup>th</sup> December 2020, coinciding with the introduction of Tier 4 as part of the "Local COVID-19 Alert Levels" regulations. This upward trend continued following the introduction of the new national restrictions on the 6<sup>th</sup> of January 2021 (when all areas of England were moved into Tier 4). This reflected more proactive policing of the regulations in the context of the danger to public health and represented a shift to move more quickly to enforcement where there were clear breaches of the law.

Enforcement levels during January and early February 2021 had returned to levels seen in the first period of restrictions in March and April 2020, with a peak of 3,294 FPNs issued between 10<sup>th</sup> – 16<sup>th</sup> April 2020 (during the week of the Easter Bank holiday). After this initial high level of enforcement, there was a considerable reduction in enforcement activity as the restrictions were progressively eased, particularly in England. This low number of FPNs issued continued from June to early September, after which there was a gradual increase as restrictions were tightened. This was then followed by a dip in the number of FPNs issued between late November to mid-December 2020 as restrictions were relaxed after the end of the second national restrictions. The number of FPNs issued began to rise again following the tightening of national restrictions on the 6<sup>th</sup> January 2021.

Since 4<sup>th</sup> February, enforcement levels have steadily declined, and as restrictions have started to ease in March and April 2021 this downward trend has continued, with 745 FPNs having been issued in the last full week (9<sup>th</sup> to 15<sup>th</sup> April 2021), compared with 910 FPNs in the previous week. Enforcement levels are now lower than those in May 2020, when national restrictions were about to be eased, when the average number of FPNs issued weekly was 1,633 (1<sup>st</sup> - 28<sup>th</sup> May 2020). The chart shows that these figures are likely to be revised upwards as more fines are processed.


Of all enforcement notices issued in England and Wales:

- The most common reason(29,817) for which an FPN was issued in England was a "Contravene a requirement to not participate in a gathering in the Tier 4 area of two or more people private dwelling/any indoor space" whereas the most common reason (3,366) in Wales was "Contravene requirement to not participate in a gathering in private" (Table 1).
- The large majority (over 7 in 10) were issued to males (Table 2).

- 75% were issued to the under 35s; with 47% issued to 18-24-year olds, 17% to those aged 25-29 and 12% to those aged 30-34 (Table 3).
- Of those FPNs where the individual issued with the notice had a self-identified ethnicity<sup>3</sup> recorded, 76% were issued to people who self-identified as White. 12% went to those who self-identified as Asian and 7% to those identifying as Black (Table 4).

#### Headline figures for FPNs issued under the face coverings regulations, England and Wales


A total of 612 notices have been recorded as having been issued by police forces under the Wearing of Face Coverings on Public Transport Regulations between 15<sup>th</sup> June 2020 and 18<sup>th</sup> April 2021, and 2,980 notices have been issued under the Wearing of Face Coverings in a Relevant Place Regulations between 24<sup>th</sup> July 2020 and 18<sup>th</sup> April 2021.

#### Face coverings on public transport

A weekly count of FPNs issued under face coverings on public transport regulations has shown that an average of fourteen FPNs have been issued each week (with 612 notices issued between 15<sup>th</sup> June 2020 and

18<sup>th</sup> April 2021). The number of FPNs issued peaked at 73 FPNs in the first week of February following the introduction of restrictions in January. As restrictions ease, the number of FPNs issued per week have returned to similar levels seen prior to the tightening of restrictions. In the last full week 5 FPNs were issued under face coverings on public transport regulations ( $5^{th} - 11^{th}$  April).

Chart 2: FPNs issued under Face coverings on public transport regulations between 24<sup>th</sup> July 2020 and the last full week ending 11<sup>th</sup> April 2021



Further breakdowns of FPNs issued under the Face coverings on public transport regulations are presented below.

- The vast majority of FPNs issued under this regulation type were issued to males (around 8 in 10).
- Over half (55%) were issued to individuals aged between 18 and 29.
- Of the 460 records where ethnicity was provided, the majority (58%) were issued to individuals who self-identified as White, a lower proportion than other FPNs. This may reflect public transport being more prevalent in metropolitan areas.
- Metropolitan Police issued most of such FPNs to date (239 out of 612) for individuals not complying with the transport regulations, followed by BTP (236).
- Most FPNs issued under these regulations were for contravening the requirement to wear a face covering when on public transport (576 Table 5).



#### Face coverings in a relevant place

Between 24<sup>th</sup> July 2020 and 18<sup>th</sup> April 2021, 2,980 FPNs were issued under face coverings in a relevant place regulations. Very few FPNs were issued in the first couple of months that the regulations were in place. However, at the start of October the number of FPNs increased with 78 FPNs issued between 2<sup>nd</sup> and 8<sup>th</sup> October 2020. The number of FPNs issued each week remained around this level before declining in late November. Number of FPNs issued rapidly increased following the January 2021 restrictions, with 250 FPNs being issued in the second week of February. They have since been declining, with 14 FPNs issued in the most recent week (9<sup>th</sup> -15<sup>th</sup> April).

Further breakdowns of FPNs issued under the Face coverings in a relevant place regulations are presented below.

- The majority of FPNs issued under this regulation type were issued to males (75%).
- Less than half (43%) were issued to individuals aged between 18 and 29.

• Of the 2,495 records where ethnicity was provided, the majority (69%) were issued to individuals who self-identified as White.



#### Headline figures for FPNs issued under the international travel regulations, England

A total of 639 notices have been recorded as having been issued by police forces under the International Travel regulations between 8<sup>th</sup> June 2020 and 18<sup>th</sup> April 2021.

The number of FPNs issued was low in the first 2 months the regulations were in place. However, in September and October the number of FPNs increased, with 28 FPNs issued between  $12^{th}$  and  $18^{th}$  October. Following the introduction of the second national lockdown, FPN numbers decreased rapidly. By December, an average of 12 FPNs were issued per week ( $30^{th}$  November –  $27^{th}$  December). Since the January restrictions were introduced the number of FPNs being issued has fluctuated with peaks of 40 FPNs ( $25^{th}$  -  $31^{st}$  January 2021), and 34 FPNs ( $1^{st}$  -  $7^{th}$  March 2021). The issuing of FPNs has been declining since the end of March, with 6 FPNs being issued in the most recent week ( $5^{th}$  –  $11^{th}$  April).

Further breakdowns of FPNs issued under the International Travel regulations are presented below.

- The vast majority (68%) of FPNs under this regulation were issued to males (Table 7).
- Less than half (46%) were issued to individuals under 35 (Table 8).
- Of the 523 records where ethnicity was provided, the majority (65%) were issued to individuals who self-identified as White. 23% were issued to Asian individuals, and 8% to Black individuals (Table 9).
- Metropolitan Police issued the most FPNs to date (103 out of 639) for individuals not complying with the international travel regulations.
- Most FPNs issued under these regulations were for "Person arrives in England fails to self-isolate" (597 – Table 10).

#### **Understanding the data**

These data cover the number of FPNs issued under COVID-19 regulations which came into effect from 27th March 2020.

Data presented in this release represent the number of FPNs issued. While the vast majority of FPNs relate to a single individual, some people have been issued with an FPN more than once. An FPN can be issued for more than one reason.

Figures on the number of FPNs issued should not be seen as a measure of the amount of police activity involved in policing the new measures, or the level of public non-compliance, since fines are issued as a last resort after initial attempts to engage with the public to explain and encourage compliance with the new regulations have not been successful.

Owing to the time taken to process FPNs, figures presented here are likely to underestimate the volume of FPNs issued each day and will be updated with each release as new data are received, although the rate of increase in revised data has slowed significantly.

The nature of the administrative process involved in issuing an FPN is such that there is sometimes missing data or discrepancies when data are returned. For example, as ethnicity is self-defining this is not always completed, and the level of missing data needs to be considered when interpreting such figures.

Force level figures are presented for England in Annex A and Wales in Annex B. However, caution should be taken to make comparisons between forces as variation in is likely to reflect a range of factors including how

the force has decided to police non-compliance as well as differences in local context (e.g. composition and density of the local population).
