## £250 million social care funding:

Half of the £250 million allocated to protect and grow social care services is being provided to support the implementation of integration by protecting and expanding social care. The remaining £125 million will help local authorities meet existing costs and deliver the joint aspiration of providing the Living Wage.

This significant enhancement in resources will allow local authorities to commission care from the independent and voluntary sectors on the basis that people are being paid £8.25 an hour – giving up to 40,000 care workers, mainly women, who are doing some of the most valuable work in Scotland, a pay rise.
