Our plan to reduce energy bills

The cost of living crisis, driven by increasing energy bills is incredibly difficult for many people in our region and across the country but we have a glimmer of good news.

As the network operator for the North West, our charges are added to bills to allow us to fund the billions that we invest in the network to keep the overhead lines and underground cables delivering power to homes and businesses.

We are proposing to reduce our part of the bill by 5.5% from April 2023 taking our part of bills down to less than £80 a year. We are committing to this at the same time as committing to increase investment by more than 30% - investing £1.8bn in the region by 2028.

We'd love your support in sharing this good news with constituents showing the value we provide to the region. A number of our engineers have been stopped while going about their essential jobs by members of the public asking why their bills are going up, but the reality is, our costs are reducing. It's important that this is recognised and that it is our investment that will enable renewable energy and new technologies like electric vehicles and solar to thrive in the North West for years to come.



New CEO, Ian Smyth, joins Electricity North West

Power network operator issues safety message

Ongoing negotiations with Ofgem

Our investment plans including our bill reduction proposals are not yet fully signed off by energy regulator, Ofgem who will conclude their decision-making in December. Unfortunately Ofgem's draft determination, published as a consultation in July, proposed unexpected and damaging changes to our plan.

We have identified a significant number of errors of calculation, logic and methodology in the Draft Determination that require correction to achieve Ofgem's stated policy intentions.

We are pleased to see some of the specific requests of our customers and stakeholders reflected in the Draft Determination, however, stakeholders also tell us they are concerned about why the cost allowances in the Draft Determination seem to be severely cut, when there is little evidence that the cost base or unit costs are inefficient. Stakeholders fear that the cuts Ofgem are proposing will mean that core elements of our business plan will become unviable.

Stakeholders have also noted that several other strongly supported proposals are currently excluded from the Ofgem determination, placing particular emphasis on the need for ring-fenced funding to support decarbonisation activities. Elected officials in Greater Manchester, Lancashire and Cumbria have already written to Ofgem directly seeking a change. We would value your support in ensuring the North West's network gets the investment it needs over the next five years.

We have proposed a 5.5% reduction in our part of annual electricity bills bringing network costs down to less than £80 a year for NW bill payers.


