

Demands on the police forces in England and Wales during the Covid-19 pandemic**Introduction**

This release presents the latest data on the demands being placed on the 43 territorial police forces in England and Wales during the Covid-19 pandemic.

The latest figures cover the 4-week period ending 14th March 2021 and are compared with the equivalent 4-week period in 2020 which was prior to the changing trends that we saw at the start of the first national lockdown last year.

Calls for Service

The latest figures show a continuing fall in calls to the police though the rate of reduction is lower than reported last month. The latest month's falls (compared with the same month in 2020) showed a fall of 13% in 999 calls and a 9% reduction in 101 calls (Table 1).

Calls for service generate incident recording which can be categorised by broad themes (Table 2). The volume of incidents related to reports of missing persons was down 14% (lower than the 30%, 25%, 20% falls reported in the last 3 monthly reports). There was a 2% reduction of incidents related to mental health (similar to the level as reported last month when it was down 3%).

There was a 3% reduction in recorded domestic abuse incidents and follows a 5% decrease reported in the last month. Domestic abuse incidents are a measure of concerns that have been brought to the attention of the police. Not all such incidents will result in a crime being identified and recorded. Nor will hidden abuse be captured in these data.

Crime

In the first few months of the restrictions, we reported marked falls in most crime types compared with the equivalent period in 2019. As restrictions were eased over the summer months many crime types started to return to pre-pandemic levels. However, as we re-entered tighter restrictions, trends in crime fell once again compared with the same time period in 2020. The latest figures show smaller reductions than seen in recent months and it might be expected that trends will start to return to more normal levels as restrictions are further eased in the coming weeks (Table 3).

Whereas there had been a fall in rape offences reported in recent months, the latest figures show a small year on year rise of 1% compared with the same 4-week period a year earlier. Reductions continued to be seen in other contact-crimes including assaults (including both Grievous Bodily Harm and Actual Bodily Harm) and robbery committed against individuals. For these types of crime, the closure of the night-time economy continues to be a key driver.

We also continue to see large reductions in high volume crimes such as burglary, vehicle-related theft and shoplifting albeit at lower rates than reported in recent months. As public health restrictions are eased it is possible that these trends will change.

The latest figures showed a rise (of 19%) in assaults on emergency workers, following an increase of 14% reported last month. As previously reported, these offences are recorded in relatively low volumes and can fluctuate from one period to the next. It is thought the rise may be driven by increases in common assaults on police constables, including suspects spitting on officers while claiming to be infected with Covid-19.

The police in England and Wales recorded a total of 97,968 Covid-19 related incidents in the 4 weeks to the 14th March 2021. This was a similar level to that reported in last month's update (99,555). These levels of incidents are higher than were seen before restrictions were tightened and is likely to be driven by an increase in reports to the police of people breaching the public health regulations.

Understanding the data

The data reported here is based on a new ad hoc NPCC collection instituted to inform Operation Talla. The purpose was to provide a mechanism for monitoring and tracking demands on the police during the Covid-19 outbreak to inform operational decisions.

A small number of key indicators have been collated from the 43 territorial forces in England and Wales by the NPCC team. We are aware that not all forces have been able to supply consistent returns across all indicators. The data should be viewed as provisional, having been gathered at speed, and as only indicative of recent trends.

In this release, we have restricted our reporting to those indicators that we have confidence are sufficiently robust to provide a reliable picture.
